**Richard D. Pomp** is the Alva P. Loiselle Professor of Law at the University of Connecticut School of Law and an adjunct professor of law at New York University Law School in the L.L.M. Program in Taxation. Professor Pomp has been admitted as an expert witness in more than 30 states and the federal district courts and has appeared in more than 120 cases. Professor Pomp has also served as a consultant to cities, states, the Multistate Tax Commission, the Navajo Nation, the U.S. Congress, the U.S. Treasury, the Department of Justice, the IRS, the United Nations, the IMF, the World Bank, and numerous foreign countries, including the People's Republic of China, the Republic of China, Indonesia, the Gambia, Zambia, Mexico, the Philippines, Pakistan, India, and Vietnam. He is the former director of the New York Tax Study Commission. Under his tenure, New York restructured its personal and corporate income taxes and created an independent tax court. In 2007, he received the NYU Institute on State and Local Taxation Award for Outstanding Achievement in State and Local Taxation. In 2011, he received the Bureau of National Affairs (BNA) Lifetime Achievement award. He was the 2012 winner of the University of Connecticut's Faculty Excellence in Teaching - Graduate Level. Tax Analysts selected him as its 2013 State Tax Lawyer and Academic of the Year. In 2014, he received the Council on State Taxation's Excellence in State Taxation award. The *Connecticut Law Tribune* selected him for a 2015 Professional Excellence Award. He recently won the Perry Zirkel '76 Distinguished Teaching award.

**Jenny Schuetz** is a fellow in Brookings Institution's Metropolitan Policy Program. She is an expert in urban economics and housing policy, focusing particularly on housing affordability. Jenny has written extensively on land use regulation, housing prices, urban amenities, and neighborhood change. She has appeared in the *New York Times*, *Wall Street Journal*, *Washington Post*, *The Economist*, *The Atlantic*, and *Vox*. Before joining Brookings, Jenny served as a principal economist in the division of consumer and community affairs at the Board of Governors of the Federal Reserve System. She was an assistant professor at the University of Southern California and a post-doctoral fellow at New York University's Furman Center for Real Estate and Urban Policy. Jenny is a non-resident senior fellow at George Washington University's Center for Washington Area Studies and teaches in Georgetown's urban planning program. Jenny earned a PhD in public policy from Harvard University, a master's in City planning from the Massachusetts Institute of Technology, and a BA with Highest Distinction in economics and political and social thought from the University of Virginia.

**Kirk Stark** is the Barrall Family Professor of Tax Law and Policy at the University of California – Los Angeles. Professor Stark’s research focuses on taxation and public finance, with an emphasis on state and local tax policy and U.S. fiscal federalism. His work has examined fiscal disparities among the states, the federal government’s role in state tax reform, and the question of how best to allocate fiscal responsibilities among federal, state, and local governments. Stark is the author of *War and Taxes* (with Steve Bank and Joe Thorndike), a political history of U.S. tax policy during wartime, as well as two leading casebooks, *Federal Income Taxation* (with Joseph Bankman and Daniel Shaviro) and *State and Local Taxation* (with Walter Hellerstein, John Swain, and Joan Youngman). Professor Stark regularly testifies on state and local tax policy before the California state legislature and has also served on the board of directors of the National Tax Association. In 2008, he was a visiting professor at Harvard Law School, and he served as vice dean for faculty development at UCLA School of Law from 2010-2013.
