The Lincoln Institute of Land Policy is an independent, nonpartisan organization whose mission is to help solve global economic, social, and environmental challenges to improve the quality of life through creative approaches to the use, taxation, and stewardship of land. The Lincoln Institute has been engaged in the preparations for Habitat III since 2014, with a focus on helping cities make the most of land, both spatially and fiscally. We have served as a co-lead of the Habitat III Policy Unit on Municipal Finance and Local Fiscal Systems, helped lead the General Assembly of Partners Research and Academia Constituent Group, served as a member of the U.S. National Committee for Habitat III, and provided expertise to the Policy Unit on Urban Spatial Strategies: Land Market and Segregation. With the adoption of a draft New Urban Agenda in September 2016, we are now focused on the critical work of implementation.
